RANGE SAFETY RULES

VIOLATION OF ANY RULES OR POLICIES MAY RESULT IN THE LOSS OF RANGE PRIVILEGES AND REMOVAL FROM THE PREMISES WHEN DEEMED NECESSARY BY THE RANGE STAFF.

PLEASE READ AND INITIAL BY EACH OF THE RANGE RULES, THEN SIGN AND DATE BELOW.

- _____ Ear and eye protection must be worn AT ALL times in the range.
- _____ Drug and alcohol use is prohibited. No is is allowed in the range under the influence of alcohol or any other controlled substance.
- _____ All firearms entering or leaving the range must be **UNLOADED**.
- _____ Personal firearms must be unloaded and cased until at a shooting station.
- _____ Firearms must be pointed down range at all times and **NEVER HIGHER THAN THE TARGET**.
- _____ Unaimed or uncontrolled fire is strictly prohibited. All shots must be fired at approved targets. You are financially responsible for any damage that you cause to the facility. Failure to report such an incident will jeopardize your use of the facility.
- _____ All ammunition is to be purchased at the American Tactical Systems facility.
- _____ The American Tactical Systems Range will suspend your membership if you become pregnant and will reinstate your remaining time free of charge.
- _____ Holsters of any kind are **NOT PERMITTED**.
- _____ Only the American Tactical Systems ammunition is to be used on the range.
- _____ Only one person may fire from a shooting booth. Exchange of weapons with another person is prohibited.
- _____ Firearms, magazines, and ammunition may only be handled in shooting booths.
- _____ **NO RAPID FIRE**. One shot per second rule applies.
- _____ **DO NOT BRING A LOADED OR MALFUNCTIONING FIREARM OFF THE RANGE EVER!** If there is a problem lay the firearm on the bench, with the muzzle pointed down range, and notify staff immediately.
- _____ **NEVER** cross the firing line or proceed in front of the barriers.
- _____ **NO** food or beverages are allowed in the range area.
- _____ **NO** policing of brass.
- _____ **DO NOT** throw brass in garbage cans. Please push brass forward when finished shooting.
- _____ **FIREARMS MAY ONLY BE HANDLED IN SHOOTING STALLS OR WHEN ASSISTED BY THE FIRING LINE STAFF.**
- _____ **ANY TIME A CEASEFIRE IS CALLED, PLACE YOUR FIREARM ON THE BENCH AND BACK AWAY FROM THE FIRE LINE IMMEDIATELY.** Any shooter is allowed to call a ceasefire for any safety violation at any time.
- _____ **THE RANGE EMPLOYEES HAVE UNQUESTIONABLE AUTHORITY REGARDING THE OPERATION OF THE RANGE.**
- _____ Shooters may only fire guns on shooters permit or guns rented from the American Tactical Systems facility.

RIFLE RANGE RULES

- _____ Target must always be placed at 25 yards when shooting a rifle.
- _____ Targets must always be placed so that the muzzle of your rifle is parallel with the ground.
- _____ Members caught shooting steel ammunition will have their membership permanently cancelled **WITHOUT REFUND**.
